

MINUTES - SPECIAL MEETING – DECEMBER 4, 2006

- 1) A special meeting of the Hillsboro Community Unit School District No. 3 Board of Education was called to order by President Bill Clinard at the Unit Office at 6:00 p.m.
- 2) The following members of the Hillsboro Board answered present to roll call: Barbara Adams, Doug Donaldson, Lynne Hutchison, Bill Jones, Bill Jurgena, and Bill Clinard. Absent: Secretary Trina Britton.
- 3) Pres. Clinard entertained a motion to appoint a secretary for the expulsion hearing, in the absence of Trina Britton. Upon a motion by Bill Jurgena, seconded by Doug Donaldson, move to appoint Lynne Hutchison secretary for the student disciplinary hearing. Voice vote. Motion carried.
- 4) Pres. Clinard entertained a motion to appoint a hearing officer for the expulsion hearing. Upon a motion by Vice-Pres. Jones, seconded by Doug Donaldson, move to appoint Pres. Clinard to preside over the student disciplinary hearing. Voice vote. Motion carried.
- 5) Upon a motion by Vice-Pres. Jones, seconded by Bill Jurgena, move to go into executive session at 6:03 p.m. for the purpose of a student discipline/expulsion hearing. On roll call the following voted yes: Barbara Adams, Doug Donaldson, Lynne Hutchison, Bill Jones, Bill Jurgena, and Bill Clinard. Motion carried, 6 - 0.
- 6) Upon a motion by Vice-Pres. Jones, seconded by Doug Donaldson, move to return to open session at 6:12 p.m. Voice vote. Motion carried.
- 7) Upon a motion by Vice-Pres. Jones, seconded by Bill Jurgena, move that “Student X” be found to have violated school rules under circumstances so related to the school program so as to warrant discipline for being under the influence of marijuana in the educational environment. On roll call the following voted yes: Doug Donaldson, Lynne Hutchison, Bill Jones, Bill Jurgena, Barbara Adams, and Bill Clinard. Motion carried, 6 - 0.
- 7) The board remained in open session.
- 8) Upon a motion by Vice-Pres. Jones, seconded by Doug Donaldson, move that the removal from school of “Student X” is approved and ratified by this Board of Education and that “Student X” be expelled from the Hillsboro Community Unit School District No. 3 for a period of one calendar year, beginning December 5, 2006 and ending on December 4, 2007. The length of this expulsion from school will be reduced to the remainder of this school year, if the student successfully completes a drug rehabilitation program. During this expulsion period “Student X” will remain away from all school district facilities. He will not be allowed to attend any student activities. On roll call the following voted yes: Lynne Hutchison, Bill Jones, Bill Jurgena, Barbara Adams, Doug Donaldson, and Bill Clinard. Motion carried, 6 – 0.
- 9) Upon a motion by Bill Jurgena, seconded by Doug Donaldson, move to adjourn. Voice vote. Motion carried.
- 10) Meeting adjourned at 6:15 p.m.
