

MINUTES - SPECIAL MEETING – FEBRUARY 20, 2007

- 1) A special meeting of the Hillsboro Community Unit School District No. 3 Board of Education was called to order by President Bill Clinard at the Unit Office at 6:00 p.m.
- 2) The following members of the Hillsboro Board answered present to roll call: Barbara Adams, Trina Britton, Doug Donaldson, Lynne Hutchison, Bill Jurgena, and Bill Clinard. Absent: Bill Jones.
- 3) Pres. Clinard entertained a motion to appoint a hearing officer for the expulsion hearing. Upon a motion by Bill Jurgena, seconded by Secy. Trina Britton, move to appoint Pres. Clinard to preside over the student disciplinary hearing. Voice vote. Motion carried.
- 4) Upon a motion by Bill Jurgena, seconded by Secy. Trina Britton, move to go into executive session at 6:02 p.m. for the purpose of a student discipline/expulsion hearing. On roll call the following voted yes: Barbara Adams, Trina Britton, Doug Donaldson, Lynne Hutchison, Bill Jurgena, and Bill Clinard. Motion carried, 6 - 0.
- 5) Upon a motion by Secy. Britton, seconded by Bill Jurgena, move to return to open session. Voice vote. Motion carried.
- 6) Upon a motion by Doug Donaldson, seconded by Bill Jurgena, move that “Student C” be found to have violated school rules under circumstances so related to the school program so as to warrant discipline for defiance, unwillingness to cease aggressive actions in the educational environment. On roll call the following voted yes: Trina Britton, Doug Donaldson, Lynne Hutchison, Bill Jurgena, Barbara Adams, and Bill Clinard. Motion carried, 6 - 0.
- 7) The board remained in open session.
- 8) Upon a motion by Secy. Britton, seconded by Bill Jurgena, move that the removal from school of “Student C” is approved and ratified by this Board of Education and that “Student C” be expelled from the Hillsboro Community Unit School District No. 3 for a period of fourteen (14) calendar weeks, beginning February 21, 2007 and ending on June 4, 2007. During this expulsion period “Student C” will remain away from all school district facilities. He will not be allowed to attend any student activities. On roll call the following voted yes: Doug Donaldson, Lynne Hutchison, Bill Jurgena, Barbara Adams, Trina Britton, and Bill Clinard. Motion carried, 6 – 0.
- 9) Upon a motion by Bill Jurgena, seconded by Doug Donaldson, move to adjourn. Voice vote. Motion carried.
- 10) Meeting adjourned.
