#### 6.1 Presentation of Summer School Plan

Curriculum Director Hope McBrain stated summer school will be open to PreK-12 if needed. Summer school will run May 30<sup>th</sup> through June 16<sup>th</sup>. It will be held Tuesday-Thursday for 8:00am to 11:00am. PreK through 5<sup>th</sup> grade will have one 75-minute block for math and one 75-minute block for ELA. Students will also have a 20-minute enrichment consisting of art, PE or library. Junior high students will have three 50-minute periods. Students will complete literature and language, math and STEM as well as a 20-minute enrichment period. The high school will be focusing on credit recovery. Each student will be getting breakfast and lunch daily. The board will be asked for approval at next month meeting.

## 6.2 Review and Discussion of Student Cell Phone Policy

High School Principal Heyen stated currently students are to have phones silenced/off and put away during class. Students are allowed to have their phone during passing periods and lunch time. Junior High Principal VanGiesen stated students currently are allowed access during lunch and recess only. Litchfield currently has a total

ban and it has been working well. Students are required to keep their phone in their locker all day, they have been socializing more with each other more and playing games during lunch. The board would like to see a plan presented on what a total ban for students would look like. Item will be placed on the March agenda.

#### 7) Agenda Item 7.0 Recognition of Audience

Many parents addressed the board with complaints that the district is not dealing with bullying. Sara Duff and Melissa Rice both have children in the district that have repeatedly been bullied by peers. They are demanding change and people be held accountable. Nicole Huber stated staff members are not following the handbook and students are not only being bullied by peers but by staff members as well. Superintendent Powell stated that due to confidentially specific accusations cannot be addressed. He assured them the district is working very hard daily on these issues and will continue to work hard to prevent and investigate bullying.
