4.05 Consideration of Mine Activity Study

Jeremy Connor of Hurst-Rosche presented information to the board. They have received a proposal from Terracon for the geotechnical engineering services at HHS proposed building site. The lump sum fees are as follows:

Desktop Review Study \$7,900

InSAR Data Review \$25,000

Traditional Geotechnical Scope \$19,000

4.2 Consideration of Summer School Plan

Curriculum Director Hope McBrain stated summer school will be open to PreK-12 if needed. Summer school will run June 6th through June 23rd. It will be held Monday-Thursday for about 3 hours. There will be about 20 students per grade level. The high school will be focusing on credit recovery. Each student will be getting breakfast and lunch daily.

4.3 Discussion of Industrial Arts Programming and Staffing

Superintendent Powell reported there is an increase in student interest in the building trades program as well as the DIY class. Principal Heyen stated in DIY I there are 49 students signed up which would mean 3 sections of about 16 students. In DIY II there are 26 signed up which would be 2 sections of 13 students. We have 18 Hillsboro students signed up for Building Trades and 10 out of district students. 28 students would be too many students for one section of Building Trades. Mrs. Heyen will continue to search for an additional Industrial Arts Teacher.

4.4 Presentation of Parent and Employee Survey Results

Superintendent Powell reviewed the survey results with the board and the audience. The summary report will be posted on the website for viewing.

4.5 Consideration of Award of Bid for 4 New School Buses

Transportation Director Adam Gregg reported Central States Bus Sales, Inc came in with the lowest bid. The cost per 77 passenger gasoline engine unit is \$118,189. The cost per 66+1 wheelchair accessible gasoline unit is \$125,032. The district will be purchasing a total of 4 buses.

Motion by Barbara Adams, seconded by Nathan Kirby to approve the purchase of (3) 77 passenger gasoline engine buses and (1) 66+1 passenger gasoline engine bus from Central States Bus Sales, Inc. On roll call the following voted yes: Barbara Adams, John Lentz, Bryce Rupert, Kassie Greenwood, Dan Tester, Nathan Kirby and Matt Lentz. Motion carried 7-0.

4.6 Consideration of Purchase of 3 New Vans

Transportation Director Adam Gregg is also recommending purchasing three 2022 Ford Transit Connect vans. The price per van is \$26,941. Mr. Gregg suggests one van be used at the Drivers Education vehicle and the other two will be replacing two of our current 2010 Town and Country vans.

Superintendent Powell is recommending approval of this two-year agreement between the Montgomery County Taxing Bodies and Vistra Energy. The agreement states that for this taxing year the EAV will be \$14,250,000 and in the following tax year \$10,250,000.
