3) Agenda Item 3.0 Discussion and Possible Action on 2020-2021 District Re-Opening Plan

Discussion was held for more than two hours. Supt Powell stated there were two significant changes to the original plan that was presented July 14th, 2020 at the regular scheduled meeting. One being, students will not all be eligible for free/reduced breakfast and lunch. The other change was presented by HHS Principal Heyen. Students lunch hour and flex period will be eliminated adding four extra minutes to each class period.
