- 1) A regular meeting of the Board of Education was called to order by President Matt Lentz, at the Hillsboro Unit Office at 7:00 p.m. The following board members were present: Barb Adams, John Lentz, Bryce Rupert, Kassie Greenwood, Dan Tester and Matt Lentz. Nathan Kirby was absent.

- 5) Agenda Item 5.0 Old Business
 - 5.1 Summer School Report

Curriculum Director Hope McBrain reported summer school is running at Beckemeyer Elementary as well as the Junior High and High School. There are 134 elementary students working with 40 staff members. Students are loving it and really making great gains. There are currently only 12 junior high students attending working with 5 staff members. The 26 high school students are focusing on credit recovery.

5.2 Amended FY2022 Budget Hearing

Supt Powell reported there is no new information to present, everything is the same from the May regular meeting.

Motion by Barb Adams, seconded by John Lentz to approve the FY2022 Amended Budget as presented. On roll call the following voted yes: Barb Adams, John Lentz, Bryce Rupert, Kassie Greenwood, Dan Tester and Matt Lentz. Motion carried 6-0.

5.3 Discussion of Hillsboro High School Building Project

Superintendent Powell stated the Building and Grounds Committee along with Hurst Rosche began planning in March of 2021 for the high school project. Over the last 10 years the district has gotten a lot of feedback from the community since the initial referendum in 2010. The common thoughts on the project are that it needs to be smaller and less expensive, the building should stay on the hill, the new building should be tied into the existing buildings, there should be no property tax increase and it has to be able to meet programming needs.

Tim Downen of Hurst Rosche presented what the \$23 million, 65,000 sq. foot site would look like. It would include a new gym, administration and guidance counselor offices, 12 new classrooms and science lab/classrooms.

Supt Powell anticipates that only \$13 million in property tax bonds will need to be approved by the voters in the school district. School facility sales tax could provide \$7.5 million and ESSER grant funds could cover \$2.5 million. The hope is with board approval a referendum will be placed on the November ballot. The item will be placed on the regular scheduled July meeting.

6) Agenda Item 6.0 New Business

6.1 Consideration and Award of Commercial Insurance Renewal

Supt Powell presented the options for the commercial insurance renewal. The Board decided to renew the current coverage in the amount of \$253,025.

Motion by Barb Adams, seconded by Dan Tester to renew the commercial insurance in the amount of \$253,025. On roll call the following voted yes: Barb Adams, John Lentz, Bryce Rupert, Kassie Greenwood, Dan Tester, and Matt Lentz. Motion carried 6-0.

6.2 Discussion of Homeschool Student Participation in Extracurricular Programs

Supt Powell stated this discussion comes up every few years. The school districts current policy does not allow homeschool students to participate in extracurricular programs. The policy states that students who are enrolled at least half a day are allowed participation. He then invited Brian Patton to speak to the board. Mr. Patton is asking for the half day requirement to be reconsidered. He stated over 210 districts are currently allowing homeschool participation in Illinois. Supt Powell stated that homeschool students participating in extracurricular activities must also meet IHSA and IESA guidelines which contain academic progress requirements. President Lentz is recommending the Policy Committee review and discuss the current policy.

6.3 Discussion of Fan Behavioral Expectations and Sportsmanship Program

Supt Powell stated that during June closed session the idea of reexamining the athletic discipline policy was discussed. Neither he nor the administration team recommend changing the policy. President Lentz would like to also discuss sportsmanship and fan behavioral expectations. Board member Adams suggested adding the items to the Policy Committee meeting.

8) Agenda Item 8.0 Executive Session
