- **Section 3.** The Superintendent of Schools is hereby authorized and directed to take any and all reasonable steps to sell the equipment, including by advertisement in local media or other methods designed to publicize the availability of the same.
 - **Section 4.** All proceeds from the sale shall be deposited in the District's Transportation Fund.
 - **Section 5.** That this Resolution shall be in full force and effect forthwith upon its passage.
