# **Regular Meeting Minutes**

# February 13, 2024

 A regular meeting of the Board of Education was called to order by President Matt Lentz, at the Hillsboro Unit Office at 7:00 p.m. The following board members were present: Matt Lentz, John Lentz, Brian Patton, Blake Furness, Mike Cerutti, and Nathan Kirby. Kassie Greenwood was absent.

### 2) Agenda Item 2.0. Good News Reports

Principal Heyen congratulated junior student Jaide-Olivia Sloan-Williams. Her art show entry was accepted to the 2024 Annual High School Art Exhibition hosted by SIUE Department of Art and Design. With over 200 entries her artwork was one of 85 chosen pieces from surrounding high schools in Missouri and Illinois.

Mrs. McBrain announced the district art teachers are collaborating with the Hillsboro Library and the Heartland Art Gallery to host a reception on May 9<sup>th</sup>. District students PreK-12<sup>th</sup> grade will have their artwork on display in the basement of the library. The top winners will be on display at the Heartland Gallery for the remaining month of May. Mrs. McBrain also stated that on February 15<sup>th</sup> the district will be hosting its first Science Olympiad for elementary students led by fourth grade teacher Erin Hammann. The junior high students will be attending a regional Science Olympiad held in Belleville on March 2<sup>nd</sup>. The district recently received a Farm to Table Grant from the USDA and ISBE. The grant allows the district to partner with a local farmer to bring fresh ground beef to the students.

Director McBrain is recommending a non-renewal the Inquiry Journey series at Beckemeyer Elementary. The staff will use some of the resources from Journey to develop a map of units, standards and resources. A new digital social studies series for the junior high being recommended. As information is added and history occurs it will be updated, no more textbooks. No action taken. The board would like more time to review.
