- This scholarship will be announced at the Hillsboro H.S. Honors Night Program by a member of the Hillsboro Educational Foundation Board of Directors
- One \$1000 scholarship will be awarded, depending upon resources available.
- The student must be pursuing an education in the civics, social studies or government sequences. (Law Enforcement was recently added to this list by Mrs. Goyak before she passed away in 2017)

## **FUNDING**

- Funding for this scholarship is made possible through the generous donation of \$20,000 by Mrs. Elizabeth Goyak in 2001.
- Proceeds were invested in First Community Bank CD#7402 in the amount of \$20,277.65. (Original amount \$20,000 donated plus accumulated interest less amounts withdrawn for funding scholarships since 2001.)
- On 6/01/13, the amount remaining was transferred to a National Bank Money Market account in the amount of \$16, 269.14. The current amount available for scholarships is \$11,269.14.
